The parties agree that the Agreement is to be amended and supplemented as follows:

This Supplemental Agreement increases the state funding participation by \$36,000. Section 6. Project Cost, and Exhibits "B" Schedule of Financial Assistance and "J" State Financial Assistance (Florida Single Audit Act), attached hereto, are modified, and superseded the Exhibits of the original agreement.

Reason for this Supplemental and supporting engineering and/or cost analysis:

Due to a clerical error, an incorrect version of the original agreement which reflected an inaccurate amount of state funds was presented to the Board for local execution. This supplement corrects the error by increasing the state funding participation to the amount approved by the Small County Outreach Program application.
