Since mid-2020 Neptune, like all businesses, has seen ever increasing costs for the key materials and inputs required to manufacture best in class water solutions. These increases have affected the costs of providing service to our customers. As such, this is a notice that there will be an overall average increase of 27% for our products effective April 11, 2023.

As with our last price increase notice on January 11, 2021, we are including with this letter an updated Frequently Asked Questions (FAQs) document that will explain how our business has been affected by inflationary pressures. If you have any questions not addressed in the FAQs, please feel free to contact your Neptune sales representative.

This was a difficult, but necessary decision to make; and we understand how it impacts our customers. Therefore, we would like to express our appreciation for your ongoing support, and we are confident these changes will help us to continue providing you with the quality products and services that help you, our valued customers, #WinYourDay.

Neptune Price Increase Frequently Asked Questions (FAQs)

Your price increase letter references "rising costs in raw materials, shipping, and operating costs" can you explain to what extent you are affected?

As reported by the <u>Bureau of Labor Statistics</u>, the average annual inflation rate for the United States has risen to 8.3%. This number is an aggregate of all economic activity in the United States. [Note: inflation has risen 3.8% since our last price increase notification in October of 2021.]

In Neptune's sector, we are primarily driven by the following economic areas: raw materials, wages, and freight. Let's drill down into examples from each of these areas (as found at <u>US Bureau of Labor Statistics</u> and <u>Cass Information Systems</u>):

- Raw materials PPI Index for Metal Products Copper Base Castings USBLS
 - o Inflation April 2020 April 2022 is 71.6%
 - Copper inflation since our last price increase communication (October 2021 March 2022) is 8%
- Raw materials PPI for Electronic Component Manufacturing USBLS
 - o Inflation April 2020 April 2022 is 11.8%
 - New data reference not in last price communication.
- Wages Employment Cost Index Wages and salaries for private industry workers in all industries and occupations USBLS
 - o Inflation March 2022 versus March 2020 was 8%
 - Wage inflation since our last price increase communication (October 2021 March 2022) was 1.4%
- Freight Cass Freight Index <u>Cass Information Systems</u>
 - o Inflation April 2020 April 2022 is 49.3%
 - Freight inflation since our last price increase communication (October 2021 March 2022) was 11%

As you can see, our business environment has been significantly affected by inflationary pressure. The aggregate increase in the example areas we have provided above is 32.2% since our last increase communication. This pressure is much higher than the 8.3% reported as the aggregate inflation rate.



Why is this price increase happening now?

In the time since our last price increase Neptune has absorbed the further pricing pressure that we documented above. We absorbed that pricing pressure so we would not impact your vital business. However, we have reached a point where we are required to raise pricing so that we can maintain the same levels of quality and service that you, as our valued partner, appreciate.

Should I expect further price increases from Neptune?

Economists generally agree that we will continue to see higher than average inflationary pressure throughout 2022 and into 2023. Our current price increase anticipates short-term inflationary pressure, and we will re-evaluate pricing levels as it becomes necessary.
