OF RESOLUTION OF THE BOARD COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA, APPROVING A STATE-FUNDED GRANT AGREEMENT WITH THE STATE OF FLORIDA **DEPARTMENT** TRANSPORTATION FOR CONSTRUCTION ACTIVITIES ASSOCIATED WITH THE ANDERSON SNOW ROAD AT CORPORATE BLVD INTERSECTION IMPROVEMENTS PROJECT; AUTHORIZING THE CHAIRMAN TO EXECUTE THE STATE-FUNDED GRANT AGREEMENT (SFGA) ON BEHALF OF HERNANDO COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Hernando County has proposed a Project, described in Exhibit A to the State-Funded Grant Agreement as "Construction Activities of the Anderson Snow Road at Corporate Boulevard Intersection improvements project. The project will expand the intersection including, at a minimum, signalization and turn lanes on all approaches."; and

WHEREAS, the State of Florida Department of Transportation has proposed participation in funding for the Project through a State-Funded Grant Agreement (SFGA) with Hernando County; and

WHEREAS, the State of Florida Department of Transportation has agreed to provide financial assistance to Hernando County in the amount of \$5,246,925.00 for the construction activities associated with the Project through FPN 450591-1-54-01, subject to execution of a State-Funded Grant Agreement (SFGA); and

WHEREAS, the Board of County Commissioners of Hernando County desires to enter into the State-Funded Grant Agreement (SFGA) with the State of Florida Department of Transportation for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION 1. The State-Funded Grant Agreement between the State of Florida Department of Transportation and Hernando County for the Project described as construction activities of the Anderson Snow Road at Corporate Boulevard Intersection Improvements project, a copy of which is attached hereto as Exhibit "A", is hereby approved.

SECTION 2. The Chairman of the	Hernando County Board of County Commissioners is
hereby authorized to execute the State-Fund	ed Grant Agreement on behalf of Hernando County.
