BRIEF OVERVIEW

On July 30, 2024, the Board approved Contract No. 24-TFG00704/AP Construction Services Under \$500K for Grant Projects (Agenda Item No. 14279), pre-qualifying firms under four categories, A-Public Works, B-Waterways, C-Utilities, and D-Facilities, to provide quotes for County projects as needed.
