TITLE

State Funded Grant Agreement With State Department of Transportation for Construction Activities Associated With Fort Dade Avenue Resurfacing Project and Associated Budget Resolution

BRIEF OVERVIEW

A State-Funded Grant Agreement between the Florida Department of Transportation (FDOT) and Hernando County has been received for funding of the construction activities associated with the construction activities of the Fort Dade Avenue from CR48/Cobb Road to US 98/SR 700/Ponce De Leon Boulevard resurfacing project.

The funding for this project was applied for through the Small County Outreach Program (SCOP) in 2020. Hernando County has completed the design of the project using inhouse staff. The resurfacing of the roadway will increase the life of the roadway and bring the section of roadway up to the Pavement Condition Rating in line with the pavement management program.

An associated grant resolution and budget resolution are attached to this item for the Board's consideration and approval.

FINANCIAL IMPACT

The grant will provide the County reimbursement by the FDOT up to \$473,037.00 for construction activities. The grant has a local participation requirement in the amount of \$157,679.00 and any expenses incurred over the \$630,716.00 agreement amount will be the responsibility of Hernando County. The local participation amount is available in the additional LOGT 1-5 Fund Account 1022-03241-5909967 (Budget Reserves-Capital). Funding will be transferred into the Transfer Grant Match Account 1022-34601-3999078 (Revenue) and appropriated to Account 1022-34601-5616306 (Expenditure) if the agreement and budget resolution are approved.
