QUESTIONS AND ANSWERS

1. Question: What is the County's anticipated level of grant support under this contract?

Answer: Total estimated costs are \$28,751,576. Total grant funding is \$14,480,000. Grants make up 50.4% of estimated costs. Actual bid prices are expected to exceed estimates based on market conditions.

2. Question: In paragraph 11.3, item 11.3.7 of the RFQ, a project is listed for the Wiscon WTP. At the pre-submittal meeting, it was indicated that the projects listed in the RFQ are more specifically identified in the Water Master Plan. The Water Master Plan does not identify the Wiscon WTP, but does list other plants. Which facility in the Water Master Plan describes the Wiscon WTP?

Answer: On page 135 of the WMP, Wiscon WTP is listed under the 2025 group of CIP projects. The description and cost estimate are there as well. It is also shown in Appendix A, CIP Spreadsheet, page 164/194 overall page count.

3. Question: The first paragraph detailing "Tab 3, Section B, Project Team" states: List in detail the members of your project team and the expertise each will bring to the project. Submit resume and work experience for a maximum of 10 primary team members, with a maximum of 3 pages for each team member. It appears the County is requesting brief bios detailing expertise of all team members, followed by resumes of 10 primary/key team members. If this is the case, how many pages are we allowed for brief bios of each project team member? Can you please clarify page counts for this section?

Answer: Submit a maximum of ten (10) primary team members with a maximum of three (3) pages per team member.

4. Question: What is the page limit for Section B - PROJECT TEAM: List in detail the members of your project team and the expertise each will bring to the projects?

Answer: See No. 3 above.

5. Question: Regarding RFQ Section 7, TAB 3, Section C – PAST EXPERIENCE - Is there a formal page limit for this section as a whole?

Answer: Submit a maximum of five (5) projects and not more than two (2) pages per project.

6. Question: Regarding RFQ Section 7, TAB 3, Section D – HERNANDO COUNTY WORK – this section requests project examples “in which your firm was either the prime Consultant, a joint Consultant or a Sub- Consultant.” Similar to previous RFQ responses, will personnel County experience having been performed while employed with past firms serve as acceptable project examples for this section?


Answer: Hernando County project experience by any team member may be submitted in this section. Experience by team members while employed with other firms is acceptable.

7. Question: Under “Section B – Project Team,” one of the disciplines required is Environmental. Can you tell us what you are defining as “Environmental”? We just want to make sure we are putting the right person in this role.

Answer: Environmental includes design of water and wastewater piping and pumping systems, water and wastewater process design, and incidental engineering required to complete project. Wetland and wildlife issues must also be addressed when necessary.
