WHEREAS, the Chairwoman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-12 on November 8, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from November 10, 2024, up to and including November 16, 2024; and,

WHEREAS, the Chairwoman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-13 on November 15, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from November 17, 2024, up to and including November 23, 2024; and,

WHEREAS, the Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-14 on November 22, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from November 24, 2024, up to and including November 30, 2024; and,

WHEREAS, the Vice Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-15 on November 25, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from December 1, 2024, up to and including December 7, 2024; and,

WHEREAS, the Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-16 on December 6, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from December 8, 2024, up to and including December 14, 2024; and,

WHEREAS, the Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-17 on December 13, 2024, which extended

WHEREAS, the Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-18 on December 20, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from December 22, 2024, up to and including December 28, 2024; and,

WHEREAS, the Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2024-19 on December 27, 2024, which extended both of the declared states of emergency in Hernando County by seven days, from December 29, 2024, up to and including January 4, 2025; and,

WHEREAS, as Chairman of the Hernando County Board of County Commissioners, as the Official Authority, adopted Proclamation No. 2025-01 on January 3, 2025, which extended both of the declared states of emergency in Hernando County by seven days, from January 5, 2025, up to and including January 11, 2025; and,

WHEREAS, there are still many areas affected by flooding in Hernando County and by the continued threat of flooding; and,

WHEREAS, residents of Hernando County are in the process of clean-up efforts in their communities, which entails removing downed trees, debris and restoring homes that were affected by wind and water damage; and,

WHEREAS, pursuant to Section 252.38, Florida Statutes, Declarations of Local States of Emergency may be extended in seven-day increments; and,

WHEREAS, Section 252.38, Florida Statutes, states that it is the innate responsibility of local government to safeguard the life and property of its citizens; and,

WHEREAS, Hernando County must take timely emergency measures because of the heightened potential for injury or damage to life and property within the County; and,

WHEREAS, pursuant to Section 21-204, Hernando County Code of Ordinances, when a quorum of the board is unable to meet, the chairman of the board, or in the absence of the chairman, the vice chairman is hereby designated and empowered as the official authority to declare a state of local emergency whenever the official authority determines that a natural or manmade disaster of emergency has occurred or that the occurrence or threat of one is imminent and requires immediate and expeditious action, and when a quorum of the board is unable to meet, the chairman of the board, or in the absence of the chairman, the vice chairman is hereby designated and empowered as the official authority to execute orders and rules whenever the official authority determines that a natural or manmade disaster or emergency has occurred or that the occurrence or threat of one is imminent and requires immediate and expeditious action.

NOW, THEREFORE, BE IT RESOLVED, by the Chairman of the Board of County

Commissioners of Hernando County, Florida, this 20th day of January 2025, that:

- 1. The Declaration of Local Emergency, Proclamation No. 2024-04, for **Hurricane Helene**, dated September 23, 2024, as it was subsequently extended by Proclamation Nos. 2024-05, 2024-06, 2024-08, 2024-09, 2024-10, 2024-11, 2024-12, 2024-13, 2024-14, 2024-15, 2024-16, 2024-17, 2024-18, 2024-19, and 2025-01, is hereby extended for an additional seven days from the effective date of this extension, unless terminated or modified earlier or extended in accordance with law. All emergency powers that Proclamation 2024-04 authorized are retained and continued for the duration of this extension.
- 2. The Declaration of Local Emergency, Proclamation No. 2024-07, for **Hurricane Milton**, dated October 6, 2024, as it was subsequently extended by Proclamation Nos. 2024-08, 2024-09, 2024-10, 2024-11, 2024-12, 2024-13, 2024-14, 2024-15, 2024-16, 2024-17, 2024-18, 2024-19, and 2025-01, is hereby extended for an additional term of seven days from the effective date of this extension, unless terminated or modified earlier or extended in accordance with law. All emergency powers that Proclamation No. 2024-07 authorized are hereby retained and continued for the duration of this extension.
