

1 **RESOLUTION NO. 2024 - 077**

2 A RESOLUTION OF THE HERNANDO COUNTY BOARD OF COUNTY
3 COMMISSIONERS ADOPTING A LIST OF SPECIFIC PROJECTS WHICH WILL
4 BE FUNDED WITH THE PROCEEDS OF THE ONE-CENT LOCAL
5 GOVERNMENT INFRASTRUCTURE SURTAX FOR COMMUNITY
6 INVESTMENT AND PROVIDING AN EFFECTIVE DATE.

7 WHEREAS, Fla. Stat. § 212.055(2), the “Local Government Infrastructure Surtax Act,”
8 authorizes Hernando County to impose a local government infrastructure surtax (of up to one per
9 cent (1%) upon most taxable transactions occurring within Hernando County that are taxable under
10 Fla. Stat. Chapter 212; and,

11 WHEREAS, the Hernando County Board of County Commissioners (the “Board”) has
12 enacted Ordinance Number 2024- 06 _____, in which it authorized, pending voter approval,
13 the imposition of a one cent (1¢) local government infrastructure surtax (the “Surtax”); and,

14 WHEREAS, the Board finds that it is necessary and proper to adopt a list of specific projects
15 to be funded with Hernando County’s share of the proceeds from the Surtax.

16 **NOW, THEREFORE, BE IT RESOLVED BY THE HERNANDO COUNTY BOARD**
17 **OF COUNTY COMMISSIONERS:**

18 **Section 1.** The Board hereby adopts the plan for the use of Hernando County’s share of the
19 proceeds of the Surtax (the “Plan”) that is attached hereto as Exhibit “A.” The Plan provides for the
20 use of such revenues to pay any portion of the costs of the Plan. The Board, at its discretion, may use
21 proceeds from the Surtax to (i) pay any portion of the costs associated with the Plan’s
22 implementation, (ii) servicing bond indebtedness the proceeds of which are used to finance any

1 portion of the costs of the Plan, and (iii) the making of lease payments pursuant to lease purchase
2 agreements heretofore or hereafter entered into for the acquisition of any portion of the Plan, and (iv)
3 funding any portion of the costs of additional capital projects meeting the requirements of Ordinance
4 2024- 06 if the Plan has already been fully implemented. The specific projects to be funded with
5 the proceeds of the Surtax may be modified from time-to-time as the Board determines to be in the
6 best interest of the citizens of Hernando County.

7 **Section 2.** The Clerk of the Circuit Court and Comptroller shall forward a certified copy of
8 this Resolution to the City Clerk of the City of Brooksville.

9 **Section 3.** The proper officers of Hernando County are hereby authorized to do all things
10 necessary and proper to carry out the terms and conditions of this Resolution which shall take effect
11 immediately upon its adoption.
