We hope you're having a great week so far! FHFC has issued a new RFA, 2024-205, and we would like to submit our site in Hernando again while we wait on word whether the previous submission was funded or not. The new RFA requires a Local Government Contribution of a face value of \$20,000 in the form of a grant, loan, or waiver. Would you be able to help us source an impact fee waiver for \$30k, we're adding a bit of cushion in case FHFC makes any changes, so we can resubmit the application in hopes of an award? I have attached the FHFC fee waiver form for Arbors at Suncoast for signature.

The application is due shortly, and having this contribution is a threshold requirement for funding so any help would be super appreciated.
