Acceptance of Emergency Medical Services Matching Grant From State Department of Health for Purchase of Intravenous Infusion Pumps for Hernando County Fire and Emergency Services and Associated Budget Resolution

BRIEF OVERVIEW

The Florida Department of Health (DOH) provides a grant opportunity annually through an EMS Matching Grant. The DOH funds 75% of the grant and 25% is funded through local funds. Hernando County Fire and Emergency Services (HCFES) is requesting Board approval for the acceptance of the grant funds to purchase thirty (30) intravenous infusion pumps, pump kits, cables, adapter and carry bags. These devices have become standard practice in hospitals to administer critical fluids to patients in order to reduce medication errors. HCFES currently administers fluid medications manually.

FINANCIAL IMPACT

The grant award is for \$48,089.00 with a cost match of \$16,030.00, totalling \$64,119.00. Attached is a budget resolution to acknowledge the additional grant funding in Fund 1691 HCFR.

The Board is authorized to take action on this matter pursuant to Chapter 125, Florida Statutes.

RECOMMENDATION

It is recommended the Board approve and authorize the Chairman's signature on the attached associated budget resolution to acknowledge the grant award.
