This estimate was produced by our office under contractual agreement with the Florida Legislature, and it is one factor used in determining the distribution of state revenue sharing funds (Section 186.901, Florida Statutes, Revenue Sharing Act, 1972). We ask that you evaluate this estimate carefully and make the appropriate response on the enclosed form. Please complete the enclosed form and email it in PDF format to <u>RichardLDoty@ufl.edu</u> (preferred method), or mail it back in the postage-paid envelope. If future correspondence to your office should be directed toward a different person or address than the one listed, please indicate that change on the form.

These 2022 estimates are based on the April 1, 2020 Census population counts. BEBR has estimated population change between the Census counts and April 1, 2022. Any challenges to the 2020 Census counts must be filed with the U.S. Census Bureau through either the 2020 Census Count Question Resolution (CQR) program¹, 2020 Post-Census Group Quarters Review (PCGQR)², or through a Special Census³.

You have the right to challenge the population <u>change</u> from the 2020 Census count to the 2022 estimate if you believe that change is not reasonably accurate. You may do so by providing an alternative estimate, along with information to support the revision. This challenge must be received by our office by **September 9, 2022**. We will review your challenge thoroughly and objectively, and we will notify you of our response to your challenge.

¹ The CQR operation allows governmental units the opportunity to request that the Census Bureau review their boundaries and/or housing counts to identify errors that may have occurred while processing their 2020 Census counts. The deadline for filing is June 30, 2023. See https://www.census.gov/programs-surveys/decennial-census/decade/2020/planning-management/evaluate/cqr.html.

² The PCGQR is a new and one-time operation that allows governmental units to request that the U.S. Census Bureau review the population counts of group quarters they believe were not correctly counted as of April 1, 2020. The deadline for filing is June 30, 2023. See <u>https://www.census.gov/programs-surveys/decennial-census/decade/2020/planning-management/evaluate/pcgqr.html</u>.

³ A Special Census is a basic enumeration of population, housing units, group quarters and transitory locations, conducted by the U.S. Census Bureau at the request of a governmental unit. Have You Had an Annexation Lately? If So, Your Population Estimate Needs Your Help

Your population estimate is important because it determines the amount of state and federal dollars that your community receives. It is essential that the state knows of your annexation in order to incorporate that area's population into your estimate.

Where to Report:

Report your annexation to the Florida Governor's Office <u>and</u> the Legislative Office of Economic and Demographic Research in order to ensure that the University of Florida knows that you had an annexation and that you qualify for all benefits available under the law.

What to Send:

- Annexation ordinance including:
 - o Ordinance number
 - Legal description
 - Map with acreage denoted
 - o Annexed land area (acres)
 - Effective date of the annexation
- Number of housing units by type of unit (single-family, multifamily, or mobile home) at the time of annexation

Population estimates are typically based on the number of active residential electric meters in your area. So, please remember to **let your electric utility company(ies) know of the annexation** to ensure the data that drive your population estimate will correctly reflect your current boundaries, both today and in the future.

Statutory Authority:

FS186.901(3): In cases of annexation or consolidation, local governments shall be required to submit to the Executive Office of the Governor, within 30 days following annexation or consolidation, a statement as to the population census effect of the action.

FS171.091: **Recording.**--Any change in the municipal boundaries through annexation or contraction shall revise the charter boundary article and shall be filed as a revision of the charter with the Department of State within 30 days. A copy of such revision must be submitted to the Office of Economic and Demographic Research along with a statement specifying the population census effect and the affected land area.

In addition to the above, please remember to file your annexation in accordance with Florida Statues 171.044(3): An ordinance adopted under this section shall be filed with the clerk of the circuit court and the chief administrative officer of the county in which the municipality is located and with the Department of State within 7 days after the adoption of such ordinance. The ordinance must include a map which clearly shows the annexed area and a complete legal description of that area by metes and bounds.
