## TITLE

Approval of Contract to HDR Engineering, Inc., for Design and Permitting Services for Landfill Cell No. 4 Expansion Project, Phase II (RFQ No. 18-R00129/PH)

# **BRIEF OVERVIEW**

On May 14, 2019, the Board awarded Contract No. 18-R00129/PH to HDR Engineering, Inc., as the top-ranked firm for Engineering Services for the Landfill Cell 4 Expansion Project (Doc ID 15656).

The project is being implemented in three (3) phases:

- Phase One (1) Site Master Planning Update and Conceptual Design (Completed)
- Phase Two (2) Detailed Design and Permitting
- Phase Three (3) Construction Phase Services.

Because the specific improvements to be designed and constructed have not been fully defined, only Phase One (1) work was initially identified in detail. HDR Engineering, Inc., has completed Phase One (1) and is prepared to move forward with Phase Two (2) of the project. Staff has successfully negotiated the cost for this phase of the project (down \$278,475.00 from the original submittal). Phase Three (3) will be presented to the Board at a future meeting.

#### FINANCIAL IMPACT

Funding is available in Account 4461-07681-5303103 (Professional Services – Engineering) in the amount of \$966,379.00.

### **LEGAL NOTE**

The Board has the authority to take the recommended action pursuant to Part II, Chapter 2, Article V of the Hernando County Code of Ordinances.

#### RECOMMENDATION

It is recommended that the Board approve Phase Two (2) of Contract No. 18-R00129/PH to HDR Engineering, Inc., of Tampa, Florida in the amount of \$966,379.00. The term of the contract is for forty-eight (48) months from Notice to Proceed (NTP) or
