

RESOLUTION NO.: 2026-116

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY AMENDING THE DESCRIPTION OF THE HERNANDO COUNTY MUNICIPAL SERVICES BENEFIT UNIT FOR FIRE RESCUE SERVICES AS CONTAINED IN RESOLUTIONS 99-112, 2005-222, 2013-7, 2015-51, AND 2017-43 AND RETAINING EXISTING ASSESSMENT RATES.

WHEREAS, the Board of County Commissioners of Hernando County, Florida (the “Board”) provides for fire rescue services, facilities and programs within the Hernando County Municipal Benefit Unit for Fire Rescue Services (the “MSBU”), and;

WHEREAS, the City of Brooksville has opted into the MSBU as authorized by Hernando County Code § 12-530; and,

WHEREAS, the inclusion of the City of Brooksville necessitates an amendment to the MSBU’s geographical description; and

WHEREAS, the Board has complied with all of the conditions precedent to the inclusion of the City of Brooksville into the MSBU; and,

WHEREAS, in the public hearing that this Resolution memorializes, the Board also voted not to increase the non-ad valorem assessments that it levies by means of the MSBU.

NOW, THEREFORE, BE IT RESOLVED BY THE HERNANDO COUNTY BOARD OF COUNTY COMMISSIONERS AS FOLLOWS:

1. The geographical description of the Hernando County Municipal Benefit Unit for Fire Rescue Services as contained in Appendix “A” of Resolution 99-112, as amended by Appendix “A” of Resolution 2005-222, as amended by Appendix “A” of Resolution 2013-7, as amended by Appendix “A” of Resolution 2015-51, and as amended by Appendix “A” of Resolution 2017-43 is hereby amended as described in Appendix “A” attached hereto and made a part hereof.

2. The inclusion of the City of Brooksville within the MSBU boundaries shall automatically sunset if the City of Brooksville enacts an ordinance revoking its consent thereto pursuant to the process set forth in Hernando County Code § 12-530(2), as it may be amended.

3. This Resolution shall be effective immediately upon adoption.

4. The Clerk shall record a copy of this Resolution in the Official Records of Hernando County, Florida, and shall send a copy of the Resolution to the City of Brooksville by certified mail, return receipt requested.
