Appointment of Citizen Member to Value Adjustment Board (Thomas E. Beisacher)

BRIEF OVERVIEW

Pursuant to the provisions of Florida Statute 194.015, the Board must appoint a citizen member to the Hernando County Value Adjustment Board (VAB). A news release was issued soliciting applications from individuals interest in filling the Board-appointed position on the VAB, due to the resignation of Dora L. Bell. As a result of the news release an application was submitted by Thomas E. Beisacher. Mr. Beisacher is a resident and elector, and owns homestead property in the County.

Pursuant to Florida Statute 194.015 the Board is authorized to act on this matter.

RECOMMENDATION

Currently, Thoms E. Beisacher serves as a member of the Board of Construction & Regulation. Board Policy 06-01 states that "...persons may serve on not more than one board/committee at a time." However, it is within the Board's discretion to appoint Mr. Beisacher to the Value Adjustment Board as a citizen member.

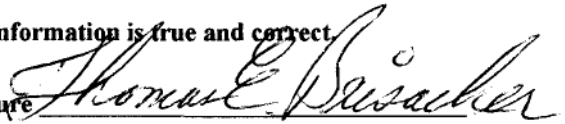
