Dear Sir/Mam,



I have received a notice of a proposed solid waste disposal assessment stating a single family residential would be \$104.40.

I am a widow residing in Brookridge Community in Brooksville. My income consist of just Social Security. Currently I am charged \$45.66 by Republic Services for a 2 day pick up. There are many times I do not put out my trash barrel due to lack of garbage, I am not alone as many seniors living alone do not accumulate a lot of trash. A increase of \$104.40 would make a big dent in my income as in other seniors.

I would like to suggest the following:

- (1) Give Seniors in low income a discount
- (2) Adjust pick up to just once a week at discount price to Seniors who don't need a 2 day pick up

I would appreciate introducing the above suggestions at the July 9th hearing.
