BRIEF OVERVIEW

The Procurement Department issued Invitation to Bid (ITB) No. 23-CG0217/AP on December 6, 2023, at the request of the Hernando County Department of Public Works to obtain bids for road paving services for the Ridge Manor Road Paving SCOP 448504-1-54-01 Faculty/Kedrone/Tombstone/Top Rock/Umbrella Rock-SFGA Project.

The Procurement Department placed the legal advertisement in the Hernando Sun on December 8, 2023, the Tampa Bay Times on December 13, 2023, and the OpenGov website on December 6, 2023. The bid was sent to two-thousand eight-hundred thirty-seven (2,837) matching vendors/contractors from the website. The bid document was downloaded by forty-one (41) vendor/contractors and four (4) bid submissions were received.

Bids were reviewed and evaluated by the Procurement Department to determine if they were responsive and responsible. The bids were then reviewed and evaluated by the Hernando County Department of Public Works and Florida Department of Transportation (FDOT) for award recommendation based on price, conformance with specifications and the Bidder's ability to perform the contract in accordance with the terms, conditions and specifications required.

A Notice of Intent to Award the contract to Goodwin Bros. Construction, Inc., dated February 27, 2024, was posted to the OpenGov website as well as posted to the Hernando County Administration electronic public bulletin board.

The Chief Procurement Officer has reviewed this requirement for conformance to procurement Ordinance and Purchasing Policies and Procedures.
