CONTRACT NO. 21-RG0010

FOR

TRANSIT OPERATOR SERVICES

The following changes, additions and/or deletions are hereby made a part of the Contract Documents for the **CONTRACT NO. 21-RG0010 – TRANSIT OPERATOR SERVICES** located in Hernando County, as fully and completely as if the same were fully set forth therein:

1. Addition of SECTION 14 – NON-REGULAR SERVICES:

a. NON-REGULAR SERVICES (NON-EMERGENCY)

Hernando County may request the Contractor RATP Dev to operate non-regular services that are in addition to the normal contracted Fixed Route and ADA services. Any such requests will be made no less than ten (10) days in advance of the date the non-regular services will be provided. The request will include general scope of services needed, date and times of service needed including starting and end time (or estimated times), number of vehicles and operators needed.

b. NON-REGULAR SERVICES (EMERGENCY)

Hernando County may require the Contractor RATP Dev to operate non-regular services that are in addition to the normal contracted Fixed Route and ADA services during emergency situations. Hernando County shall give as much notice as possible including general scope of services needed, dates, times, expected vehicle and operator needs. Emergency transportation is defined as; Hernando County deems an emergency transportation service is needed requiring transit of peoples from and to locations within Hernando County.

c. RATES AND TERMS

Compensation for non-regular services both (non-emergency and emergency) shall be in accordance with the actual Fixed Route revenue rate per hour stated in SECTION 9 COMPENSATION.

For (non-emergency) and/or (Emergency) services mobilizations, there will be a two (2) hour minimum charge per operator requested/required.

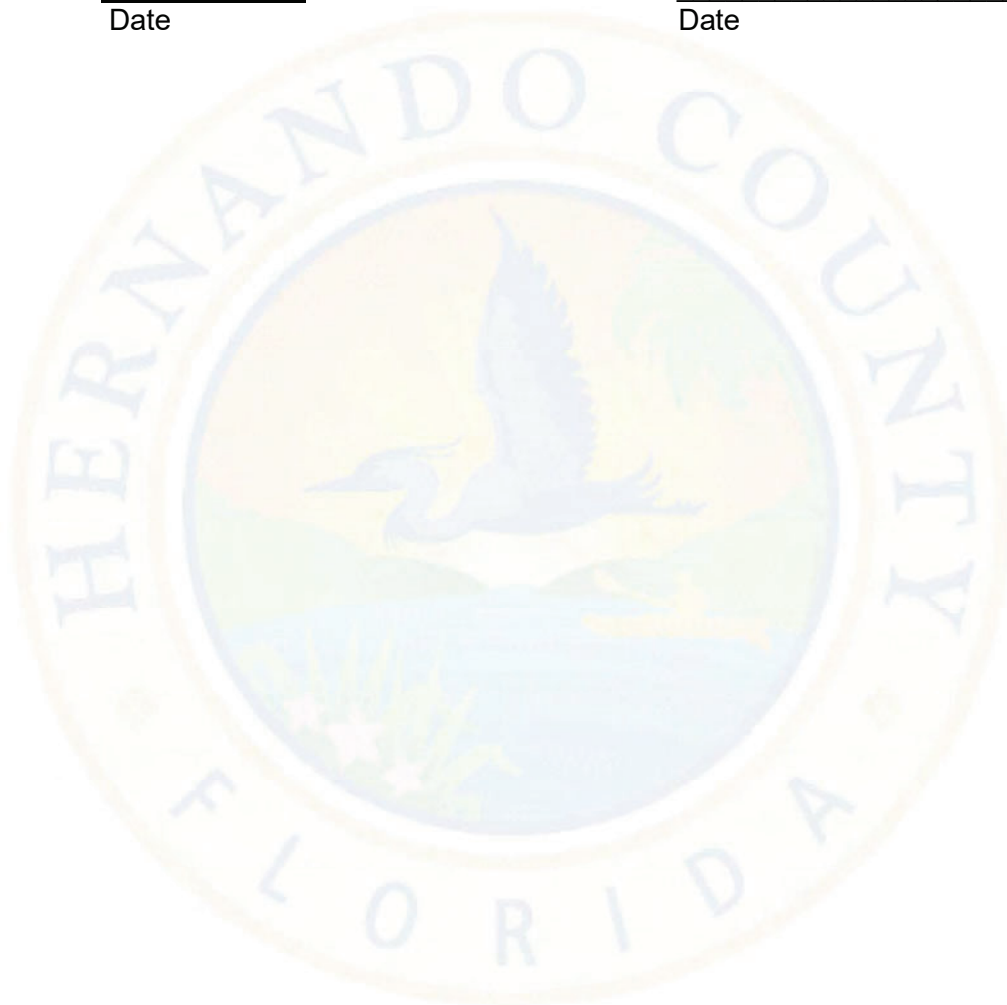
