TITLE

First Amendment to Contract No. 15-R00117 With CareATC, Inc., for Operation of Wellness Center

BRIEF OVERVIEW

On April 26, 2016, Hernando County entered into an Agreement with CareATC, Inc., under Contract No. 15-R00117 to provide Wellness Center Services.

Hernando County Human Resources Department (HR) is requesting to add optional services of a Dedicated Wellness Services Health Coach.

Aggregate data collected from Personal Health Assessments of our group have indicated members who may be at risk for chronic diseases such as cardiovascular disease, diabetes, hypertension and stroke. Under the program, qualifying members who are referred by the Wellness Center staff will be invited to participate in one-on-one confidential health coaching sessions. The Health Coach will develop personalized care plans strategically designed to address important lifestyle issues such as weight loss, tobacco use, fitness and nutrition.

Addressing and reducing health risk factors of these diseases may reduce the incidences of serious health conditions which may result in cost savings to Hernando County Medical Self-Insurance.

The cost of the Dedicated Wellness Services Health Coach for the remainder of FY 17/18 will be \$68,000.00 with an annual cost of \$100,000.00.

The Chief Procurement Officer has reviewed this requirement for conformance to Procurement Ordinance and Purchasing Policies and Procedures.

FINANCIAL IMPACT

Funds are available from Hernando County Medical Insr Self-insurance with Human Resources Department FY17/18 budget line item 08121-5303401 Medical Insurance Self-Ins – Contracted Services in the amount of \$68,000.00.
