VARIANCE is requested from the following requirement of the Hernando

FINDINGS OF FACT:

All of the facts and conditions presented to the BOCC in connection with this matter are incorporated herein by reference and made a material part of this Resolution as integral to the BOCC's action. The BOCC finds that the testimony and record supporting <u>APPROVAL</u> of the applicant's request to be credible and to constitute competent substantial evidence. In further support thereof, the BOCC makes the following specific findings of fact:

- 1. The requested **DIMENSIONAL VARIANCE** <u>does</u> satisfy all of the following prerequisites set forth in Appendix A, Article V, Section 3, Hernando County Code of Ordinances:
  - (a) That special conditions and circumstances exist which are peculiar to the land, structure, or building involved and which are not applicable to other lands, structures, or buildings in the same zoning district.
  - (b) That the special conditions and circumstances do not result from the actions of the applicant.
  - (c) That granting the variance requested will not confer on the applicant any special privilege that is denied by this ordinance to other lands, buildings, or structures in the same zoning district;
  - (d) That literal interpretation of the provisions of the ordinance would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of the ordinance and would work unnecessary and undue hardship on the applicant
  - (e) That the variance granted is the minimum variance that will make possible the reasonable use of the land, building or structure.
  - (f) That the granting of the variance will be in harmony with the general intent and purpose of the land development regulations and that such variance will not be injurious to the area involved or otherwise detrimental to the public welfare.
- 2. The requested **DIMENSIONAL VARIANCE** is consistent with the County's adopted Comprehensive Plan and land development regulations, subject to any conditions made a part of the BOCC Action in this matter and which conditions, if any, are incorporated herein by reference.

#### CONCLUSIONS OF LAW:

The BOCC is authorized to act on this matter pursuant to Chapters 125 and 163, *Fla. Stat.*, and Appendix A, Article V, Section 3, Hernando County Code of Ordinances. Accordingly, after public hearing and testimony, being fully advised in the record, and based upon competent substantial evidence, the BOCC makes the following specific conclusions of law:

1. The requested **DIMENSIONAL VARIANCE** is consistent with the County's adopted Comprehensive Plan and land development regulations, subject to all conditions made a part of the BOCC Action

in this matter and which conditions, if any, are incorporated herein by reference.

After notice and public hearing, based upon the record in this matter and ALL ACTION: of the findings of fact and conclusions of law above, the BOCC hereby **APPROVES** the requested variance.

- Any condition made a part of the BOCC action in this matter are 1. incorporated herein by reference.
- Pursuant to Appendix A, Article V, Section 3.D.(1), the 2. DIMENSIONAL VARIANCE granted herein applies to the property for which it is granted, and not to the individual who applied for it, and it is transferrable to any future owner of the land, but it cannot be transferred by the applicant to a different site.
