A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR SIGNATURE AUTHORITY FOR THE HAZARD MITIGATION GRANT PROGRAM GRANT APPLICATION DOCUMENTS ON BEHALF OF HERNANDO COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, has proposed Projects to the Hazard Mitigation Grant Program as “Clipper Court Area Flood Relief”, “Culbreath Road Area Flood Relief”, and “Old Crystal River Road Area Flood Relief”; and

WHEREAS, Hernando County has applied for funding through the State of Florida Department of Emergency Management for proposed participation in funding for the Projects through Hazard Mitigation Grant Program; and

WHEREAS, the Hernando County Board of County Commissioners has agreed to provide financial assistance per project in the amounts of \$81,250, \$762,500 & \$81,250 respectively for flood relief activities associated with the Projects, subject to an award(s) of a Hazard Mitigation Grant Program Grant Agreement; and

WHEREAS, the Board of County Commissioners of Hernando County desires to enter into the Hazard Mitigation Grant Program with the State of Florida Department of Emergency Management for the Projects.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION 1. The Hernando County Board of County Commissioners ratified the County Administrator’s signature at the October 10, 2023 Board of County Commissioners meeting for the associated Hazard Mitigation Grant Program applications on behalf of Hernando County.

SECTION 2. The County Administrator of the Hernando County Board of County Commissioners is hereby authorized to sign all Hazard Mitigation Grant Program grant application

documents as requested by the Florida Department of Emergency Management for the Hazard Mitigation Grant Program on behalf of Hernando County.

SECTION 3. This Resolution shall become effective immediately upon adoption.
