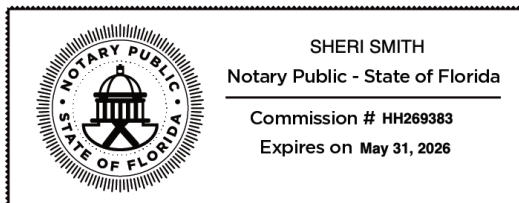

Main St, Rm 160, Brooksville, Florida, to consider the following:

AN ORDINANCE AMENDING CHAPTER 23, ARTICLE VIII, SECTION 23-265 OF THE HERNANDO COUNTY CODE, RELATING TO ADEQUATE PUBLIC FACILITIES AND FACILITY/SERVICE DEMAND CALCULATIONS; PROVIDING FOR REMOVAL OF NUMERICALLY SPECIFIED LEVEL OF SERVICE (LOS) STANDARDS FOR POTABLE WATER AND WASTEWATER TREATMENT; PROVIDING FOR INCORPORATION OF ADOPTED LEVEL OF SERVICE (LOS) STANDARDS AS ADOPTED BY RESOLUTION IN EFFECT AT THE TIME OF CONCURRENCY DETERMINATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.
