Alisa,

The school beacons that we are purchasing are FDOT approved product listed Carmanah Technologies R829-G Series beacons. Carmanah Technologies is the brand name of the beacon, however, in the state of Florida the only vendor that sells these units is Temple, Inc.

A better way of understanding how this works, is to use an example. I will use Kleenex tissues as the example. Kleenex tissues are made by Kimberly-Clark, however, when I want to buy the tissues, I go to the drug store or grocery store to purchase them, I can't call Kimberly Clark and purchase them. If I contact Kimberly Clark, they will direct me to a local vendor that sells their product.

In the case of the beacons, I want to use the Carmanah Technologies R829-G Series school beacons, they are an FDOT approved product, and since we are in the State of Florida, I need to purchase it from Temple, Inc. They are the only vendor that stock the Carmanah Technologies R829-G Series beacons in Florida, so in this situation they are the only place that Hernando County can purchase them, making them a sole source vendor.
