#### TITLE

Award of Contract to Seggie Custom Builders, LLC, for Pine Island Storm Damage Repair Project (Contract No. 23-T00040/AP; Amount: \$374,463.29)

#### **BRIEF OVERVIEW**

On September 26, 2023, the Board approved Contract No. 23-T00040/AP Request for Qualifications for Construction Services Under \$500K, Doc Id. No. 12623, prequalifying nine (9) Contractors for three (3) Construction Categories. The Procurement Department was to bring to the Board any quote that exceeded the ABR of \$35,000.00.

On December 4, 2023, the Hernando County Parks and Recreation Department solicited Quote No. 1 under Contract No. 23-TR00040/AP for the Pine Island Storm Damage Repair Project comprised of repairs of fencing, sidewalks, ramps, wooden deck for concession area, wooden ramp for overlook/pier and hauling of sand from Anderson Snow Park to Pine Island at Pine Island.

The quote was sent to the eight (8) Pre-qualified Contractors under Category D: Facilities (Fence Installation, concrete work, asphalt resurfacing, site work). Two (2) responses were received.

#### **Quotes Received**

Seggie Custom Builders, LLC \$374,463.29 Property Services GC \$463,337.00

The Hernando County Parks and Recreation Department is recommending award of Quote No. 1 to Seggie Custom Builders LLC. for the Pine Island Storm Damage Repair Project. In accordance with Procurement Ordinance and Purchasing Policies and Procedures.
