AGREEMENT FOR GROUNDS MAINTENANCE

This is an agreement by and between HERNANDO COUNTY ("COUNTY") and *THE HIGH POINT COMMUNITY PROPERTY OWNERS, INC.* REQUESTOR") for reimbursement from COUNTY and for assumption of liability and provision of insurance coverage with respect to providing grounds maintenance of the county-owned properties described below. The type of maintenance work to be performed, anticipated frequency, and estimated annual cost is provided. The COUNTY'S liability for reimbursement inany fiscal year under this agreement shall not exceed the total estimated annual reimbursement set forth below. Reimbursement pursuant to this agreement shall be made upon presentation of records, invoices and/or receipts sufficient for COUNTY to determine that the right to reimbursement exists. The COUNTY reserves the right to conduct an audit of REQUESTOR'S record to confirm the accuracy and/or propriety of reimbursement requests, and REQUESTOR, agrees to make such records available at reasonable times upon COUNTY request therefor. Reimbursement is based on the services which the COUNTY would have provided only. Any premium cuts beyond this contract are at the discretion and the financial responsibility of the REQUESTOR. The maintenance work described shall be performed by REQUESTOR, its agents or contractors, subject to the provisions below.

Maintenance shall include but is not limited to all mowing, edging along sidewalks and litter removal, as outlined in the attached subdivision map, eight (8) times per year.

Annual maintenance of County rights-of-ways along High Point Boulevard (approximately 3.1 miles) and one (1) Drainage Retention Area (DRA) on Western Circle, all included within the High Point Subdivision, as indicated on attached map.

Total Annual reimbursement amount is \$7.553.00 for referenced areas; paid quarterly at \$1.888.25.

REQUESTOR agrees to indemnify fully and hold harmless COUNTY, its officers, agents, and employees from and against all losses, damages, claims, liabilities, and causes of action of every kind or character and nature as well as costs and fees, including reasonable attorney's fees connected therewith, and the expense of the investigation thereof, based upon ort arising out of damages or injuries to third persons or their property caused by the willful conduct or negligence of REQUESTOR, its agents or contractors inperforming the work contemplated by this Agreement. COUNTY shall give to REQUESTOR prompt and reasonable notice of any such claims, or actions and REQUESTOR shall have the right to investigate, compromise and defend the same to the extent of its own interest.

REQUESTOR or its agents or contractors actually performing reimbursable maintenance work under this agreement shall provide, pay for and maintain with companies satisfactory to COUNTY the types of insurance described herein from responsible insurance companies eligible to do business in Florida. Insurance coverage and limits required herein are designed to meet the minimum requirements of COUNTY and are not designed as a recommended insurance program for REQUESTOR.

Required insurance per County Policy for all informal bids/quotes:

1) WORKERS' COMPENSATION: As required by law:

State Applicable Federal Employer's Liability – Minimum Statutory Statutory \$100,000 each accident \$100,000 each employee \$500,000 policy limit

 GENERAL LIABILITY: Comprehensive General Liability including, but not limited to, Independent Contractor Contractual Premises/Operations, and Personal Injury covering the liability assumed under indemnification provisions of this contract, with limits of liability for personal injury and/or bodily injury, including death. Coverage as follows:

General Aggregate \$2,000,000
Personal/Advertising Injury \$1,000,000
Products-Completed Operations Aggregate \$2,000,000

- 1) ADDITIONAL INSURED: Contractor agrees to endorse Hernando County as an additional insured on the Commercial General Liability. The Additional Insured shall read "Hernando County Board of County Commissioners." Proof of Endorsement is required.
- 2) WAIVER OF SUBROGATION: Contractor agrees by entering into this contract to a Waiver of Subrogation for each required policy herein. When required by the insurer, or should a policy condition not permit Contractor to enter into a pre-loss agreement to waive subrogation without an endorsement, then Contractor agrees to notify the insurer and request the policy be endorsed with a Waiver of Transfer of Rights of Recovery Against Others, or its equivalent. This Waiver of Subrogation requirement shall not apply to any policy which includes a consideration specifically prohibiting such an endorsement or voids coverage should Contractor enter into such an agreement on a pre-loss basis.
- 3) AUTOMOBILE LIABILITY: Comprehensive automobile and truck lability covering any auto, all owned autos, scheduled autos, hired autos, and non- owned autos. Coverage shall be on an "occurrence" basis. Such insurance to include coverage for loading and unloading hazards. COVERAGE AS FOLLOWS:

COMBINED SINGLE LIMIT (CSL) \$300,000 BODILY INJURY (Per Person) \$100,000 BODILY INJURY (Per Accident) \$300,000

This Agreement is made with the understanding that it may be terminated at any time, with or without cause, by either party, upon thirty (30) days written notice. The Agreement otherwise is valid until September 30, 2025 at which time the Agreement may be renewed for an extended period shall both parties agree.

Good Morning Casey,

Happy to help 😊

General Liability - Limits are met and policy in effect. You are correct that they are missing the waiver of subrogation endorsement as required in the agreement.

Auto - They have \$1M combined single limit. On a COI not all 3 of those lines will be filled in. They will either have the Bodily Injury (per person) and (per accident) lines with limits or only the Combined Single Limit since that is the combination of those two. It's all in how they insure it on their policy. Most often you'll see the combined single limit. With that said, the agreement requires \$300k and they have \$1M so they have more than what we required so its all good.

Workers Compensation - Workers Compensation is rated on a function of payroll and as an HOA they have no payroll or employees for them to insure. This would not be applicable to them.

Excess/Umbrella Liability- I did not see this required in the agreement, they don't need it. This policy would be added for higher risk/safety agreements.

Overall, the waiver of subrogation requirement needs to be met. Everything else is good.
