

**FIRST AMENDMENT TO  
INTERLOCAL AGREEMENT BETWEEN  
CITRUS COUNTY, HERNANDO COUNTY, LAKE COUNTY,  
MARION COUNTY, SEMINOLE COUNTY, AND SUMTER COUNTY  
FOR COST SHARE OF MEDICAL EXAMINER SERVICES  
AND RELATED MATTERS**

**THIS FIRST AMENDMENT** is made and entered into this 3rd day of August, 2021, to amend that certain Interlocal Agreement ("Agreement") made and entered into on the 25<sup>th</sup> day of September, 2018, between **CITRUS COUNTY** ("CITRUS"), **HERNANDO COUNTY** ("HERNANDO"), **LAKE COUNTY** ("LAKE"), **MARION COUNTY** ("MARION"), **SEMINOLE COUNTY** ("SEMINOLE"), and **SUMTER COUNTY** ("SUMTER"), all of which are political subdivisions of the State of Florida. CITRUS, HERNANDO, LAKE, MARION, and SUMTER are collectively referred to in this First Amendment as the "DISTRICT 5 COUNTIES."

**W I T N E S S E T H:**

**WHEREAS**, the parties entered into the above-referenced Agreement on September 25, 2018, to provide for cost share of medical examiner services and related matters; and

**WHEREAS**, the parties desire to amend the Agreement to add SEMINOLE as a full member of the District Medical Examiner Committee and to enable the parties to continue to enjoy the mutual benefits the Agreement provides; and

**WHEREAS**, Section 16(b) of the Agreement provides that any amendments will be valid only when expressed in writing and duly signed by the parties.

**NOW, THEREFORE**, in consideration of the mutual understandings and agreements contained in this First Amendment, the parties agree to amend the Agreement as follows:

1. Section 3(a) of the Agreement is amended to read as follows:

(a) There is hereby created a District Medical Examiner Committee consisting of one county commissioner from each of the DISTRICT FIVE COUNTIES and one county commissioner from SEMINOLE. Each county will appoint its own commissioner to the District Medical Examiner Committee. The District Medical Examiner Committee will collectively have administrative oversight of Florida Medical Examiner District 5 and Florida Medical Examiner District 24.

2. Section 3(e) of the Agreement is amended to read as follows:

(e) SEMINOLE is a full member of the District Medical Examiner Committee with all the rights and duties as each of the DISTRICT 5 COUNTIES. This Section 3 applies to SEMINOLE in the same manner as it applies to each of the DISTRICT 5 COUNTIES. However, nothing in this Agreement may be construed to mean that Florida Medical Examiner District 24 has merged with Florida Medical Examiner District 5 and each District will remain a separate entity.

3. Section 5(b) of the Agreement is deleted.


4. This First Amendment is effective on the date when the last party has properly executed this First Amendment as determined by the date set forth immediately below the respective signatures of the parties.

5. Except as modified by this First Amendment, all terms and conditions of the original Agreement remain in full force and effect for the term of the Agreement.
