#### **BACKGROUND**

I was born in Sonora, Kentucky and moved to Hernando Beach, Florida in 2014. Prior to that I was an accomplished litigation attorney in Louisville, Kentucky with more than 45 years experience in high-stakes civil litigation. I received my Juris Doctorate Degree, cum laude, from the University of Louisville School of Law and was admitted to the Kentucky Bar in April 1973. Prior to law school, I served as an Officer in Vietnam with the U.S. Army's 82<sup>nd</sup> Airborne Division's "Golden Brigade".

Over the last seven years I have attended more than 70 County Commission meetings as a volunteer, and invested hundreds of hours studying Hernando County government, policies, and process. I've used my legal skills to speak on issues to ensure the legal process has been followed. I frequently attend Planning & Zoning meetings, budget workshops, Emergency Management presentations, Local Mitigation Strategy Working Group meetings and Port Authority meetings. I worked hard to help defeat an illegitimate Brownfield Act application for property in a high density populated area of Spring Hill, advocated for Port Authority and Planning & Zoning to confer, coordinate and collaborate on all water-dependent land use changes. I worked aggressively to advocate for repeal of the county imposed 5 year 50% significant damage/significant improvement "Look Back Rule", which has now saved thousands of homes, and worked directly with county officials on this issue. For these reasons I have earned and gained the respect of many citizens of Hernando County.

Over the last seven years I have gained significant institutional knowledge about the processes and procedures of our local Hernando County government, the administration, and the staff to be an effective Planning & Zoning Commissioner.

From 2009 to 2013, I was outside trial counsel for the Attorney General, Commonwealth of Kentucky, in the National Arbitration between participating tobacco cigarette manufactures and forty-six states over the enforcement and recovery of multi-billion dollar annual payments the manufactures owed to the states under the 1998 Tobacco Master Settlement Agreement.

Before law school, I studied political science and military science at Eastern Kentucky University (EKU). During my Junior and Senior years I was elected and served as President of EKU's Interfraternity Council. I served on EKU's student court and participated in high completion national and international collegiate debates as a member of EKU's Debate team.
