FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING

THIS FIRST AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING (Amendment) entered into on <u>2 13</u>, 2018 between Hernando County, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY," and the University of Florida, Board of Trustees, hereinafter referred to as "UNIVERSITY."

WITNESSETH

WHERAS, the County and the University entered into that certain Memorandum of Understanding (Agreement) dated July 25, 2017, which provided for, among other obligations specified the terms under which the UNIVERSITY will provide personnel, educational, technical and research information to the COUNTY; and

WHEREAS, Exhibit A to the Agreement provides for funding and payments; and

WHEREAS, this Amendment to the Agreement provides for an updated Exhibit A in accordance with the adopted budgets of both parties;

NOW, THEREFORE, in consideration of the mutual covenants and provisions contained herein, the parties hereto agree as follows:

- 1. <u>Recitals</u>. The above Recitals are incorporated herein by reference and made a part hereof.
- 2. <u>Modification</u>. Exhibit A is updated in accordance with the attached. No modification of this Amendment shall be valid or binding unless such modification is in writing and duly executed by the Parties, or their respective successors or assigns.
- 3. Original Agreement; Amendment. All provisions of the Agreement not modified (whether explicitly or implicitly) by this Amendment will remain in full force and effect according to their terms. This Amendment and the Agreement shall be construed as a single document and shall be collectively referred to as the "Agreement" or this "Agreement," except to the extent the terms of this Amendment conflict or are inconsistent with the terms of the Agreement, in which case this Amendment will control.
