Use of US Communities Term Contracts for Various Services and Supplies

BRIEF OVERVIEW

In our continuing effort to streamline the procurement process, staff suggests that we utilize more piggyback contracts.

The US Communities organization has several nationally awarded, competitive let contracts. These contracts not only will allow for a lowering of purchase expenditures, but it also does not require us to expend extensive labor and dollars in the solicitation/bidding process.
