Notice is hereby given that the Board of County Commissioners of Hernando County, Florida, will hold a public hearing on Tuesday, August 23, 2022, at 9:00 a.m., or as soon thereafter as possible, in the County Commission Chambers, located in the Hernando County Government Center, 20 North Main Street, Room 160, Brooksville, Florida. The purpose of this hearing is to consider the enactment of an ordinance entitled as follows:

AN ORDINANCE OF HERNANDO COUNTY, FLORIDA, AMENDING DIVISION 2 OF ARTICLE VI OF CHAPTER 28 OF THE HERNANDO COUNTY CODE OF ORDINANCES RELATING TO WATER AND SEWER SYSTEMS; AMENDING SUBSECTION 28-238(a) OF THE CODE OF ORDINANCES PROVIDING FOR REQUIRED CONNECTIONS WITH WATER AND SEWER SYSTEMS TO PROVIDE NOTICE REQUIREMENTS FOR AVAILABILITY OF CENTRAL WATER AND/OR SEWER SYSTEMS; AMENDING SUBSECTION 28-238(d) OF THE CODE OF ORDINANCES PROVIDING SANITARY SEWER REQUIREMENTS FOR CONNECTIONS WITH WATER AND SEWER SYSTEMS TO DELETE DISTANCE REQUIREMENTS BETWEEN PROPERTY AND HERNANDO COUNTY WATER AND SEWER DISTRICT TRANSMISSION LINE (GRAVITY AND/OR FORCE MAIN); AMENDING SUBSECTION 28-238(e) OF THE CODE OF ORDINANCES PROVIDING FOR EXEMPTIONS FROM CONNECTIONS WITH WATER AND SEWER SYSTEMS TO REVISE EXEMPTIONS FROM CONNECTIONS WITH WATER AND SEWER SYSTEMS TO REVISE EXEMPTIONS FROM CONNECTIONS WITH HERNANDO COUNTY WATER AND SEWER DISTRICT SYSTEMS; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

Copies of the proposed ordinance may be inspected by the public during normal business hours at the Hernando County Utilities Department, 15365 Cortez Boulevard, Brooksville, Florida. All interested parties may appear at the meeting or public hearing and be heard with respect to the proposed ordinance.
