Award of Contract to DEEB Construction and Development Company for Linden and Deer Water Treatment Plant Fence Replacement; and Wiscon Maintenance Facility and Seville Water Treatment Plant Gate Replacement Projects (Contract No. 19-R00007/BK; Amount: \$122,294.00)

BRIEF OVERVIEW

On May 14, 2019, the Board approved Contract No. 19-R00007/BK Request for Qualifications for Construction Services Under \$200K, Doc Id. No. 15661, prequalifying nine (9) Contractors for four (4) Construction Categories. The Purchasing and Contracts Department was to bring to the Board any quote that exceeded the ABR of \$35,000.00.

On August 3, 2022, the Hernando County Utilities Department solicited Quote No. 80 under Contract No. 19-R00007/BK for the Linden and Deer WTP Fence Replacement, Wiscon Maintenance Facility and Seville WTP Gate Replacements comprised of new chain link fence, reusing the onsite chain link fence and installation of two (2) new gates at Linden and Deer Street Water Treatment Plant. Replacement of three (3) gates at the Wiscon Maintenance Facility and replacement of one (1) gate at the Seville Water Treatment Plant.

The quote was sent to the seven (7) Pre-qualified Contractors under Category A: Public Works (Fence Installation, concrete work, asphalt resurfacing, site work). Two (2) responses were received.

The Contract requires that any cost above the ABR of \$35K requires Board purchase approval.
