BRIEF OVERVIEW

Request:

Small - Scale Comprehensive Plan Amendment to change the Future Land Use on 6.9 acres from Residential to Commercial

General Location:

Northern terminus of Rolling Rock Road, approximately 520 feet north of its intersection with Cortez Boulevard

P&Z Action:

On February 12, 2024, the Planning and Zoning Commission reviewed the proposed amendment and voted 5-0 to recommend approval to the Local Planning Agency and the Board of County Commissioners as a small-scale amendment
