Declaration of County Owned Property Located on Round Table Road as Surplus Property and Consideration of Purchase Offer Submitted by Martine Dominique

BRIEF OVERVIEW

Hernando County owned Parcel Key No. 50768 is a vacant residential lot consisting of 7,769 square feet, located on Round Table Road in Hernando County.

There is one offer to purchase the subject property from Martine Dominique for the sum of \$4,500.00. The Hernando County Property Appraiser's 2021 market value based on 2020 qualified sales is \$4,040.00. The offer presented by Martine Dominique is 111% of the Property Appraiser's value.

Staff recommends the offer being made on behalf of Martine Dominique in the amount of \$4,500.00 be accepted. There are no contingent offers.
