**BRIEF OVERVIEW**

Discharge of Order and Satisfaction of Lien documents are attached for persons who have satisfied liens imposed by the Special Master for certain code violations.

These documents require Board approval to release the lien, the Chairman's signature upon the Order and the document to be recorded in the Official Records. The County received satisfaction for the liens in the amount of \$1,253.35.

**FINANCIAL IMPACT**
