Reappointment of Marguerite Wollerton and Jessica Haher as Members to Library Advisory Committee Until December 31, 2027

BRIEF OVERVIEW

The terms of three (3) regular members on the Library Advisory Committee (LAC) will expire on December 31, 2023. The regular positions are currently held by Ms. Marguerite Wollerton, Ms. Jessica Haher and Ms. Susan Loveday. Ms. Susan Loveday is not eligible for reappointment.

A news release was issued accepting applications from individuals interested in serving as a member on the LAC. As a result of the news release, applications were received from Ms. Marguerite Wollerton and Ms. Jessica Haher, who are eligible for reappointment. The applicants have been verified as being residents and registered voters in Hernando County.

The Library Advisory Committee recommended that the Board change the status of Dorothy Masumian from alternate to regular member status. One (1) vacant alternate position remains on the LAC.
