BRIEF OVERVIEW

Request:

Rezoning from AG/(Agricultural) to PDP(MF)/Planned Development Project (Multifamily) with deviations

The Applicable Criteria for a Zoning District Amendment are contained in Appendix A (Zoning Code), Article VI. The Applicable Criteria for a PDP are found in Appendix A (Zoning Code), Article VIII. The Zoning District Amendment must be consistent with the Comprehensive Plan.

RECOMMENDATION

It is recommended that the Board approve the petitioner's request for a rezoning from AG/ (Agricultural) to PDP(MF)/Planned Development Project (Multifamily) with deviations and modified performance conditions in accordance with the recommendation of the Planning and Zoning Commission.
