BRIEF OVERVIEW

On August 30, 2023, the Procurement Department issued a Request for Qualifications (RFQ No. 23-RFQ00422/AP) for continuing Professional Engineering Services seeking firms qualified to provide comprehensive general professional architectural, civil engineering, planning, and consulting services.

The solicitation was sent to two thousand eight hundred thirty-three (2,833) contractors and downloaded by eighty-nine (89).

The County entered negotiations with the top six (6) ranked firms. Those negotiations concluded April 10, 2024. Task Orders under this contract will be assigned and negotiated on a rotational basis; each task order will not exceed a total cost of \$500,000.00.

A Notice of Intent to award the contract to Coastal Engineering Associates, Inc., HDR Engineering, Inc., Stantec Consulting Services, Inc., Ayres Associates, Inc., Infrastructure Consulting & Engineering, PLLC and Jones, Edmunds & Associates, Inc., dated December 21, 2023, was posted to the OpenGov website and posted to the Hernando County Administration electronic public bulletin board. No responses were received.
