Approval of Quote to Johnson’s Excavation & Services, Inc., for R-Beach Demolition Project (Amount: \$36,790.00)

### BRIEF OVERVIEW

On October 18, 2021, the Chief Procurement Officer approved Contract No. 21-TF0075 Demolition Pre-Qualification, prequalifying seven (7) Contractors for demolition projects.

On April 18, 2023, the Hernando County Facilities Department solicited a quote for the demolition of R-Beach. The quote was sent to the seven Pre-qualified contractors. Six quotes were received.

- 1) SC Signature Construction      \$74,900.00
- 2) Cross Environmental Services      \$47,695.00
- 3) Central Florida Land Service      \$46,730.00
- 4) Cross Construction Services      \$44,400.00
- 5) TNT Environmental      \$44,700.00
- 6) Johnson’s Excavation & Services, Inc.      \$36,790.00

Hernando County Facilities Department is recommending award of quote to Johnson’s Excavation and Services, Inc., for the demolition of R-Beach.
