Final Close-Out of Contract With Augustine Construction, Inc., for Deltona Boulevard Sidewalk Local Agency Program Project From Elgin Boulevard to SR 50 (Contract No. 22-CG0024/DK; Amount: \$105,085.55)

BRIEF OVERVIEW

The Deltona Boulevard Sidewalk (Elgin Boulevard to SR 50) - Local Agency Program (LAP) Project was awarded by the Board on April 12, 2022, Doc Id. No. 19539, to Augustine Construction, Inc., in the amount of \$207,580.70.

Change Order No. One (1) was for a change order revision to the original purchase order at no cost to the County.

Change Order No. Two (2) is for field revisions increasing the Contract amount by \$78,480.42 from \$207,580.70 to \$286,061.12.

The final Contract amount is \$286,061.12 (PO No. 22000788).

The work has been completed and Augustine Construction, Inc., has submitted its Final Pay Application No. Two (2) in the amount of \$105,085.55.
