BRIEF OVERVIEW

Hernando County Fire Rescue and Emergency Services currently utilizes TimeClock Plus, LLC proprietary software for government sector fire rescue employee scheduling and payroll services.

Fire Rescue and Emergency Services staff scheduling is specific to twenty-four (24) hours seven (7) days a week operation and utilizes mutual trade days off as well as Kelly days.

This purchase is a five (5) year term for software subscription services and is billed annually in the amount of \$15,049.10 per year for a total of 288 user licenses.

Hernando County Fire Rescue and Emergency Services is requesting authorization to renew and purchase for a term of five (5) years with subscription ending October 2028 per related Order Form from Timeclock Plus, LLC:
