#### **BRIEF OVERVIEW**

Hernando County owned Parcel Key No. 1596071 is a vacant residential lot, consisting of 15,184 square feet that is located on Elm Leaf Drive.

There is one offer to purchase the subject property on this agenda item. The offer is from GTG Spire Homes, LLC for the sum of \$32,000.00. There are no contingent offers.

The Hernando County Property Appraiser's 2022 market value, based on 2021 qualified sales, is \$18,524.00. The offer presented by GTG Spire Homes, LLC is 173% of the Property Appraiser's value.

Staff recommends the offer being made on behalf of GTG Spire Homes, LLC in the amount of \$32,000.00 be accepted. There are no contingent offers.
