### **BRIEF OVERVIEW**

On July 25, 2023, the Fleet Department requested the Term Sole Source for Outside repairs with Dobbs Equipment. A sole source request for Outside Repairs is being requested to process repairs on an as needed basis for service of John Deere Construction and Forestry Equipment and allied brands.

On November 29, 2023, a Sole/Single Source Notice of Intent to award for Term Sole Source Contract No. 23-TSS00419 to Dobbs Equipment was posted per Procurement Policies and Procedures. The Procurement Department has received no communications regarding the Notice of Intent to Sole Source. The last day for receipt of information was December 20, 2023.
