These documents require Board approval to release the liens and authorize all executed documents to be recorded in the Official Records. The County received satisfaction for the liens in the total amount of \$17,408.36.

Additionally, payment was made on the following cases against Special Master Orders that have not yet been recorded. While satisfactions in such instances are not necessary, a Discharge of Unrecorded Order for each is presented for Board approval per the request of a title company. The total amount paid for these unrecorded orders is \$9,820.81.
