TITLE

Budget Resolution Recognizing Bond Proceeds From Issuance of Non-Ad Valorem Revenue Bonds, Series 2022, to Finance and Reimburse Costs of Various Improvements Within County and to Pay Costs of Issuing Bonds

BRIEF OVERVIEW

At the Board meeting on October 11, 2022, the Board approved the issuance of Non-Ad Valorem Revenue Bonds, Series 2022. The attached budget resolution adjusts the appropriate budget line items to bring them in line with these transactions.

FINANCIAL IMPACT

The FY23 Budget will be increased by \$63,959,460 to recognize the bond proceeds.
