Contract for Sale and Purchase of Leasehold Improvement With Pamela Wilfong for Warehouse and Office Building Located at 15470 Flight Path Drive (a/k/a Tracers Building) for Use as Government Offices and Associated Budget Amendment

BRIEF OVERVIEW

The Hernando County Board of County Commissioners was asked to vacate their space within the Hernando County Courthouse under the "Space Needs Project" in order to provide the Judiciary staff more room. The County has been leasing the Tracers Building located at 15470 Flight Path Drive from Pamela Wilfong. This building is located on Hernando County-owned property on Airport grounds (Key #946917). It has suitable space, convenient access and parking.

The improvements are located on the parcel legally described as follows:

The Northern 388.51' of Lot 37, Hernando County Airport Industrial Park Unit 1, as recorded in Plat Book 17, Pages 80-83, of the Public Records of Hernando County, Florida. Parcel #R-Z HAI 18 2393 0000 0370 Key #1738338
