Note: Approval requires all proposed lots to meet minimum zoning size, have a 15-foot access/utility easement, and the conveyance deed must include a bold legend regarding the unplatted status and lack of county maintenance obligation. All lots must be transferred to an **immediate family member** and contain a **reverter clause** if not kept by a family member for a minimum of two (2) years.



5. Certification and Signature

I, the undersigned developer, hereby certify that the information contained in this Petition for Relief from Hardship and all attached documentation is true and correct to the best of my knowledge. I understand that any misrepresentation of facts may result in the denial of this petition. I acknowledge that the Hernando County Board of County Commissioners may require additional data and information.
