

I am responding to your letter dated January 21, 2026, addressed to Richard Zielinski regarding the Notice of Public Nuisance for Vessel Registration #FL1693LJ, Decal #08029041. One80 Marine serves as the managing general agent for Swiss Re Corporate Solutions America Insurance Corporation ("Swiss Re"). Swiss Re issued property and liability insurance policy number 58M0005300-03 to Richard Zielinski, effective from 03/25/2024 to 03/25/2025, for his 1986 46' Bertram Convertible "EIGHTY," HIN BERP0978K687 ("the vessel").

On 10/09/2024, Hurricane Milton made landfall in Florida. During the storm, the vessel rolled in its slip and sank. Mr. Zielinski filed an insurance claim with Swiss Re, which was settled on 10/23/2024. As part of the settlement, the vessel was declared a constructive total loss, and salvage rights were transferred to Swiss Re, care of Cooper Capital Specialty Salvage, LLC ("Cooper Capital").

Cooper Capital managed the salvage for Swiss Re. In April, Cooper Capital paid Jahson Imgrund \$1,999.00 to assume ownership of the vessel. The Bill of Sale was signed and transferred to Mr. Imgrund on 04/07/2025. On 06/17/2025, a notice of bill of sale was submitted to the State of Florida Department of Highway Safety and Motor Vehicles.

Mr. Zielinski has not owned the vessel since 10/23/2024, and Swiss Re has not owned it since 04/07/2025. We respectfully request that all future communications and concerns regarding the vessel be directed to the current owner, Jahson Imgrund.
