E. BKV AIRPORT PROJECT MANAGER – ANDREW JOHNS

- Project Update
 - East Side Development – 45 Days Ahead of Schedule
 - Runway 321 in conjunction with Abandoned Runway Project – surveying and core sampling.
 - Taxiway Delta & Alpha 1 Repaving Project – Beginning Phases
 - Gunnery Backstop – Working with Parks & Recreation for maintenance. Accuform is going to provide large picture of bomber and the electrician is working on the lights.

F. ECONOMIC DEVELOPMENT UPDATE – VALERIE PIANTA

- Project Update
 - There are 28 Active Projects:
 - Airport – 21
 - County – 5
 - I-75-2
 - 14 New / 14 Expansion
 - Bluewater has had some stormwater engineering issues. They have

had to go back to the drawing board, but they are still moving forward.

- Project Bluebird – Possible Big Project coming to Hernando County and the Airport. We are one of the final 4 areas under consideration and we should know by the end of March. The project would bring 1,400 jobs and a capital investment of \$545 million dollars.
- Economic Development Funding
 - Brainstorm how to fund economic development incentive packages so that big businesses come to Hernando County.
 - Commissioner Allocco recommended allocating tangible and personal property tax to economic development. Mr. Rogers informed the committee that he is going to recommend that the tangible and personal property tax collected from the businesses at the airport go to Economic Development starting this year.
 - Other states and cities have taxes just for economic development
 - This will be a discussion point for a future meeting.
