A RESOLUTION OF THE HERNANDO COUNTY BOARD OF COUNTY COMMISSIONERS AMENDING RESOLUTION NO. 2025-195 ADOPTED ON NOVEMBER 18, 2025, RELATING TO THE EXECUTION OF A PUBLIC TRANSPORTATION GRANT AGREEMENT (PTGA) WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) UNDER THE FEDERAL TRANSIT ADMINISTRATION (FTA) SECTION 5311 PROGRAM GRANT FUNDING FOR HERNANDO COUNTY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 18, 2025, the Hernando County Board of County Commissioners (Board) voted 4-0 to adopt Resolution No. 2025-195, which authorized the execution of the Public Transportation Grant Agreement (PTGA) by and between Hernando County (County) and the Florida Department of Transportation (FDOT) for the Federal Transit Administration (FTA) Section 5311 Program Grant; and

WHEREAS, the purpose of the FTA Section 5311 Program Grant was to purchase twelve (12) 27-inch Ruggedized Intelligent Bus Infotainment Displays needed for transit service information, county information, and onboard advertising used in Hernando County's (County) fixed-route and ADA transit services; and

WHEREAS, Resolution No. 2025-195 provided that the estimated project amount was projected to be \$93,916.00, with no local matching funds; and

WHEREAS, after Resolution No. 2025-195 was signed, the total funds to be awarded for the FTA Section 5311 Program Grant was \$100,000.00, with no local matching funds, along with receipt of identifying information to the grant awarded.

NOW, THEREFORE, BE IT RESOLVED BY THE HERNANDO COUNTY BOARD OF COUNTY COMMISSIONERS:

SECTION 1. Amendment to Resolution No. 2025-195. The Hernando County Board of County Commissioners hereby amends the following sections in Resolution No. 2025-195 to read as follows (strikethroughs indicate deletions and underlining indicates additions):

a. Whereas Clause—Paragraph 6:

WHEREAS, the estimated Total Project Cost will be ~~\$93,916.00~~ \$100,000.00, with no local matching funds.

b. Section 1:

The Hernando County Board of County Commissioners hereby APPROVES and AUTHORIZES the execution of the Public Transportation Grant Agreement with the
