1 **RESOLUTION NO.: 2025 -**2 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF 3 HERNANDO COUNTY, FLORIDA, ACCEPTING DEDICATION OF RIGHTS-OF-WAY IN ACCORDANCE WITH HERNANDO COUNTY CODE 4 5 SECTION 23-268; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE 6 REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN 7 EFFECTIVE DATE. WHEREAS, Lake Hideaway Revocable Trust and Hawk Lake Hideaway, LLC (collectively, 8 9 "Developers"), entered into a Development Agreement with Hernando County (the "County"), 10 dated February 8, 2022, regarding the proposed development known as "Lake Hideaway"; and, 11 WHEREAS, a copy of the Development Agreement has been recorded at Book 4140, Page 12 1053, of the Official Records of Hernando County, Florida; and, WHEREAS, pursuant to Hernando County Code § 23-268, a developer can mitigate, in 13 14 whole or in part, the impacts that its proposed development will have on transportation facilities by, 15 among other methods, dedicating rights-of-way to the County; and, 16 WHEREAS, Developers, in Paragraph 3.18 of the Development Agreement, agreed to 17 dedicate three rights-of-way to the County as mitigation for the anticipated impacts that Lake 18 Hideaway's construction will have on the County's transportation infrastructure; and, WHEREAS, the dedicated rights-of-way are described in Exhibits "A," "B," and "C" hereto, 19 which legal descriptions are incorporated as if fully set forth herein; and, 20

It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence, phrase, or provision of this resolution is for any reason held unconstitutional or invalid, the invalidity thereof will not affect the validity of the remaining portions of this resolution. Section 3. Conflicting Provisions Repealed. All resolutions or parts of resolutions in conflict with the provisions of this resolution are hereby repealed. **Section 4.
