**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF HERNANDO COUNTY, FLORIDA, INCORPORATING
WHEREAS CLAUSES; AMENDING THE WELLHEAD PROTECTION
AREAS AND SPECIAL PROTECTION AREAS MAP; AMENDING THE
LOCATION OF THE WELLHEAD PROTECTION AND SPECIAL
PROTECTION AREA MAPS; PROVIDING FOR SEVERABILITY,
AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, on June 27, 1994, the Board of County Commissioners of Hernando County adopted Ordinance No. 94-8, which is codified as Article VII of Chapter 28 of the Hernando Code of Ordinances, entitled Groundwater Protection and Siting; and

WHEREAS, on January 13, 2026, the Board of County Commissioners adopted Ordinance No. 2026-03, which amended Section 28-265 of the Hernando County Code of Ordinances, entitled Groundwater Resource, Wellhead and Special Protection Areas; and

WHEREAS, hydrogeological modeling was completed and adopted by the Board in 1994 to establish Wellhead Protection areas (WHPA) and Special Protection areas (SPA) to ensure integrity and safety of Hernando County's drinking water; and

WHEREAS, the WinFlow hydraulic model with up-to-date technology has been developed and was approved for use by Hernando County Planning Department in 1999; and

WHEREAS, Hernando County Utilities Department (HCUD) hired a hydrogeological firm to upgrade its WHPA and SPAs in conjunction with the 2021 Potable Water Master Plan utilizing an updated model which resulted in changes to the sizes and shapes of the WHPAs and changes to the SPAs; and

WHEREAS, based on the updated Model, HCUD recommends a change to the County's WHPA and SPA maps to reflect the updated well data, to address specific development concerns, and to align with state regulations; and

WHEREAS, the County's WHPA and SPA maps, as currently adopted, are located at the County's Utilities Department; and

WHEREAS, the County has conducted a review of the proposed changes, including public notice and comment periods; and

WHEREAS, the Hernando County Board of County Commissioners finds that the WHPA and SPA maps are updated in a manner consistent with the changes in technical knowledge and the methodology and standards established within Section 28-265 of the Code.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Hernando County, Florida:

SECTION 1. Recitals. The recitals above are true and correct and are incorporated herein by reference.

SECTION 2. Findings. Pursuant to Chapter 28, Article VII, Section 28-265 of the Hernando County Code of Ordinances, the Board of County Commissioners hereby amends the WHPA and SPA maps by adding the existence of such WHPAs and changes in SPAs as indicated in the hydrologist and the water flow model and made a part thereof.

SECTION 3. The WHPA and SPA maps shall be placed on file at the County's Planning Division of the Development Services Department, the Utilities Department, and the Geographic Information Systems (GIS) office, and shall be made available for in-person viewing at the County's Utilities Administration Building.

SECTION 4. Severability. In the event that any provision, portion or section of this Resolution is determined to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining provisions, portions or sections of this Resolution which shall remain in full force and effect.

SECTION 5. Effective Date. This Resolution shall become effective immediately upon adoption.
